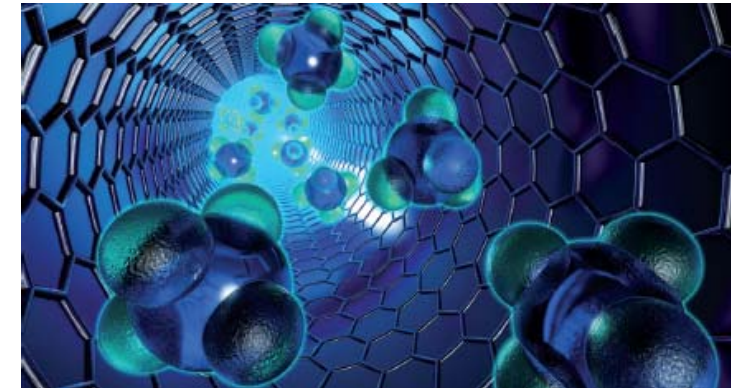

The SIINN ERA-NET promotes the safe and rapid transfer of European research results in nanoscience and nanotechnology (N&N) into industrial applications. National and regional resources will create a transnational programme of research.

SIINN will bring together today's fragmented research activities on the potential risks of manufactured nanomaterials for environment, human health, and safety.

SIINN Third Call Topics*

Funding will be offered to innovative projects focusing on Manufactured NanoMaterials (MNMs) in one of the following thematic fields:

1. Exposure assessment
2. Toxicity mechanisms
3. Effects of MNM on human health
4. Environmental impacts of MNMs

Detailed description of the topics is given in the Call Text.

* Please note that not all the Funding Organisations participating in the call will fund each of the four call topics. For details please address the contact person of your country/region.

The third joint call for transnational projects of the SIINN ERA-NET has been opened on **October 1, 2014**.

The deadline for submitting proposals is **January 16, 2015, 12:00 CET (7:00 Washington D.C. time)**.

Each consortium submitting a proposal must involve a minimum of three independent organisations from at least two regions/countries participating in the call.

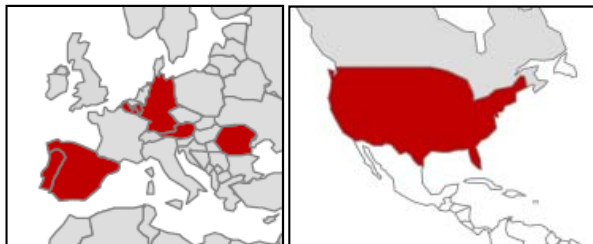
Please note that further participation rules apply.
